APPLICATION

BEFORE APPLICATION, ALWAYS DO A SMALL TEST SAMPLE IN A LESS-VISIBLE AREA TO BE SURE THERE ARE NO VARIABLES OR CONTAMINANTS IN THE SUB-STRATE THAT MAY BE INCOMPATIBLE WITH THIS PRODUCT.

IMPORTANT NOTE: Daily Cleaning and Periodic Deep Cleaning recommended to prolong the life of your surface. Improper methods and products used for daily and periodic deep cleaning are probably the main causes of damage to commercial hardwood floors. Avoid water, all-purpose cleaners and harsh chemicals (which can damage the wood or dull the finish). Also, don't use dust mop treatments, oil soaps, silicone and acrylics which can leave a residue and adversely affect the adhesion of a coat of finish in the future.

Following the correct methods is easy and relatively inexpensive:

MIXING / DILUTION RATIOS

Pentra-Clean® (DC) MUST BE DILUTED WITH WATER. THE DILUTION MUST BE BETWEEN 1% (10ML/L) AND 5% (50ML/L).

WHEN USED WITH AUTO SCRUBBERS, TYPICALLY DILUTE THE WATER IN THE TANK. IN CASE OF MANUAL USE, THE AMOUNT OF PRODUCT THAT WILL NEED TO BE APPLIED TO THE FLOOR WILL DEPEND ON THE FLOOR'S DIRTINESS.

SURFACE PREPARATION

Vacuum or Sweep to remove dirt, sand or grit that can act like sandpaper to scratch and damage the floor. Small areas, use a microfiber or terry cloth mop for larger areas, a commercial mop, buffer or autoscrubber can be used with hardwood floor cleaner to remove dirt, stains and dried spills.

PLACEMENT: APPLY PRODUCT EVENLY TO FLOOR. AGITATE/SCRUB, AND REMOVE.

CLEAN UP AND DISPOSAL

Use soap and water to clean tools and equipment. Although **Pentra-Clean® (DC)** is non-toxic and environmentally safe, it is slightly alkaline—please use responsibly.

HEALTH AND SAFETY PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN.

Pentra-Clean® (DC) is an aqueous surfactant solution that uses proprietary compounds. The treatment is neutral to mildly alkaline and may cause eye and skin irritation. Do not take internally. Avoid prolonged contact with skin. Avoid ingestion of material. If swallowed, do not induce vomiting—call physician. Avoid contact with eyes. Protective clothing is recommended. Protective goggles are recommended in case of splashing. If splashed in eyes, wash immediately with clean water and call physician if irritation persists. Contact areas should be thoroughly washed with soap and water. Additional precautions, safety information and first aid treatments are contained in the Material Safety Data Sheet.

CAUTION: Surfaces wet with **Pentra-Clean® (DC)** may be slippery.
